President's Report

Election 08: Our annual General Membership meeting, also our general election meeting, is on Friday, Nov. 21. Ballots will be cast and absentee ballots accepted. All will be counted to elect four individuals to the Board of Directors: Vice-president [Lee Frechette], Treasurer [Lois Clifton], Track Supt. [Darrell Gomes], Yard Master [Richard Lutrel]. The nominees for these offices were presented by our nominating committee to our October general membership meeting with an opportunity for floor nominations for these offices. No floor nominations were made so nominations were closed. Be sure to vote either absentee or in person on Nov. 21.

Halloween: The four nights of scary things and a haunted house brought fun and fright to hundreds of "ghost busters". Halloween at Hagan Park is a joint venture between SVLSRM and the Jerry Jewell Performing Arts "Scary U". We did the trackside events and Scary U does the Haunted House. Scary U is a non-profit group of school-age students who design, build, and operate the award-winning haunted house under a tent in the SVLSRM area with the guidance of Jerry Jewell and his associates. Several local TV stations covered the event during it's construction for presentation on their newscasts throughout their broadcast days.

The Live Steamer's goal this year was to increase the number and quality of our own trackside events. Train riders were

greeted by a talking Gargoyle atop a stone arch that warned train passengers about entering at their own risk. Riders passed several creatures that jumped, moved, screeched, and lit up in surprising ways. A skeleton engineer on a radio controlled engine and car passed by the passenger train on a parallel track cackling and laughing as he did so. Our truss bridge became a creepy, covered, fog-filled tunnel complete with demonic sounds, creatures, and strobe lights. Eerily lit ghosts floated high overhead and a graveyard with deathly sounds and chanting completed the ride experience.



Thanks to Lee Frechette, Shelly Blanchard, Bill Yoder, Pete and Betty Arney, Dennis Gramith, Kevin and Andrew Sach for the construction of the props, sound systems, pneumatics, lighting, fog, sensors, aerial tramway, and all else needed to make the trackside events a success.

However, none of this would have been possible without the participation and dedication of the volunteers that coordinated the ticket sales, operated Cordova Station, sold popcorn, and ran the trains as conductors and engineers, including several days doing so in the cold and rain. Clio Geyer lists these great volunteers elsewhere in this newsletter. Thanks, too, to Marilyn Drewes and Ross Crawford for the use of their trailer on site for the 24-hour security volunteers during the week of our event.

We learned a lot more this year about the construction and operation of an event like this. We will take this knowledge

forward to the 2009 Halloween event, beginning the planning shortly for next year. One of our goals is to meld our events into that of the haunted house for a seamless guest experience. The Pirate theme of the past two years will be gone and a new theme, yet to be finalized, will appear.

Besides providing involvement in the Rancho Cordova community as an attraction to be enjoyed, the money we earn from this one event pays for our liability insurance and some of our general operational expenses as well.

Roseville Railfair: As this is being written, the Railfair is coming up next weekend on November 8-9. With our steam engine out of service for repairs, we will this year operate SVLSRM diesels with our riding cars instead of our steam engine which is out of service for a new boiler. Paul Clifton has made calls for volunteers to help set up our portable track and run the trains over the three day Railfair at the Placer County fairgrounds in Roseville.

Rancho Cordova Christmas Tree Lighting Ceremony:

SVLSRM, under the guidance of Lee Frechette, will set up our portable track for the first time at Village Park on the Saturday after Thanksgiving, Nov. 29. This will be in preparation for the annual lighting of the City of Rancho Cordova Christmas tree on Sunday, Nov. 30. The Live Steamers will be doing this event as a public service to the local community. Volunteers are needed. Please call Lee to volunteer. Tear down will be on Monday, Dec. 1.

Winter 2008-2009 Projects: Several projects have been approved by the Board of Directors and the General Membership. Some are underway and others soon to start. All are scheduled to be done over the downtime of the Winter 2008-2009 season. Specific tasks and workdays will be developed and published so all members, close by and from a distance, can participate in the volunteer effort. Details, work days, and tasks will be posted on http://www.svlsrm.org/projects . Some of the expenses will be offset by donations and grants.

FCR #029: Electrical for Halloween haunted house and stage, RV area: \$6100. Approved, BOD: 10/14/08; General Membership: 10/17/08. FCR in progress.

FCR #030: Concrete unloading pads, steaming bays: \$3000. Approved, BOD: 10/14/08. FCR completed.

FCR #031: Irrigation water main expansion, north: \$2300. Approved, BOD: 10/14/08; General Membership: 10/17/08. FCR in progress.

FCR #032: Roadbed aggregate removal and replacement, track upgrade to steel and plastic, approx. 1000ft: \$26,520. Approved BOD 10/14/08; General Membership: 10/17/08. *FCR to be started soon*.

Volunteers: Every non-profit organization has them, from churches to civic groups to service organizations. We can't exist without them. By definition, non-profit groups are non-profit, a no-brainer. That means that the majority, if not all, of the monetary resources go to the stated purpose (mission statement) of the non-profit organization, with little or no employee expense. Unlike many service organizations, SVLSRM is rich with physical assets requiring constant maintenance and improvements. We are a dynamic organization constantly changing. We require continuing participation from our membership in the day-to-day operation and ongoing expansion and change.

SVLSRM dues for a regular member is \$60 annually, about the price of one hamburger meal per month at a fast food place. Included in the dues is the monthly newsletter and postage, voting materials, much of the membership materials for each member. Little is left for the maintenance and operation of the facility. Those funds come from our events: public run days, Fourth of July runs, Halloween, Santa Run, Meets, etc. All of these activities require member participation. In other words, \$60 doesn't pay for your participation in our organization, your presence does.

This winter, as outlined above, we begin some aggressive projects that must complete before we start up again in March, 2009. Volunteers are needed, especially from beyond our local area. And during the summer months, the Yard Master needs help with mowing and watering. The Track Superintendent always needs help with the never ending regimen of track maintenance year long.

In the August, 2008, Golden Spike, an admonition and plea made by past president Dennis Gramith 20 years ago in July, 1988, was reprinted and is still applicable now: "… In most organizations, 10 to 15 percent of the members do most of the work. With our membership at well over 100 people, we should see 10 to 15 people helping with the work of running our railroad. Wow! That would be double what we usually get. …while this sermon business may seem to be a poor way to get help, what little help it brings is vital to the task at hand and to the morale of the tiny team who are struggling to keep your club functioning. It's never too late! You can still come out and contribute your share."

Thank you, Dennis. It can't be said any better.

See you at the track. Keep on steaming!

101. Locomotives and equipment shall be unloaded and loaded only at the facilities provided for such unloading and loading. All vehicles shall be removed from the loading area as soon as possible after loading or unloading.

219. Engine whistle signals:

O = A short blast - = A long blast

- A. O Apply brakes; STOP
- B. OO Answer to any signal not otherwise provided for.
- C. OOO When standing back up; answer to 221C. When running, answer to 221D.
- D. OOOO Call for signals.
- E. -- Release brakes; proceed.
- F. ---- Flagman return to train.
- G. -OOO Flagman protect rear of train.
- H. --O- Approaching public crossing, area of restricted visibility or a train on adjacent track.
- I. OOOOOOOO (8) Warning to people or animals on track; general alarm.
- 301. The chief concern of all operating personnel shall be the safety of visitors, guests, and members of the organization.
- 415. All locomotives operating during periods of low visibility or after sunset shall be equipped with a working headlight that may be seen clearly for a distance of at least 150 feet and sufficient lighting in the locomotive cab to read the gauges and see the controls clearly.
